# 1. Design Plan (30%)

Creativity and Quality (15%): How innovative and aesthetically pleasing is the design? Does it align with the town's aesthetic guidelines?

Excellent (15-13 points): Highly creative, exceptional quality, perfectly aligns with town aesthetics.

Good (12-10 points): Creative, high quality, mostly aligns with town aesthetics.

Good (12-10 points): Uses good quality, mostly seasonally appropriate plants and materials.

Fair (9-7 points): Uses some appropriate plants and materials, but with limitations.

Poor (6-0 points): Uses inappropriate plants and materials or lacks durability.

# 2. Cost-effectiveness and Budget Adherence (20%)

Detailed Cost Estimate (10%): How clear and comprehensive is the cost breakdown for design, installation, and maintenance?

Excellent (10-9 points): Detailed and transparent cost estimate with clear justification.

Good (8-7 points): Adequate cost estimate with some detail.

Fair (6-5 points): Basic cost estimate, lacking detail.

Poor (4-0 points): Incomplete or unclear cost estimate.

Adherence to Budget (10%): Does the proposal fit within the estimated budget of \$2,000-\$6,000?

Excellent (10-9 points): Well within budget with cost-effective solutions.

Good (8-7 points): Within budget with minor adjustments needed.

Fair (6-5 points): Slightly over budget or cost-effectiveness is a concern.

Poor (4-0 points): Significantly over budget or not cost-effective.

# 3. Experience and Qualifications of the Firm (20%)

Relevant Experience (10%): Does the firm have a history of successful projects similar in scope and scale?

Excellent (10-9 points): Extensive experience with numerous relevant projects.

Good (8-7 points): Some experience with similar projects.

Fair (6-5 points): Limited experience with a few relevant projects.

Poor (4-0 points): Little to no relevant experience.

Qualifications and Certifications (10%): Are the firm's qualifications, licenses, and certifications appropriate for this project?

Excellent (10-9 points): Fully qualified with all necessary licenses and certifications.

Good (8-7 points): Mostly qualified with required licenses and certifications.

Fair (6-5 points): Some qualifications but missing key licenses or certifications.

Poor (4-0 points): Lacks necessary qualifications, licenses, or certifications.

# 4. Proposed Timeline and Ability to Meet Deadlines (15%)

Project Timeline (15%): Is the timeline realistic and does it align with the project start and completion dates?

Excellent (15-13 points): Detailed, realistic timeline with clear milestones.

Good (12-10 points): Mostly realistic timeline with minor adjustments needed.

Fair (9-7 points): Basic timeline with potential for delays.

Poor (6-0 points): Unclear or unrealistic timeline, likely to miss deadlines.

# 5. References and Past Performance (15%)

Quality of References (15%): Are the references strong and do they reflect positive past performance on similar projects?

Excellent (15-13 points): Strong references with highly positive feedback.

Good (12-10 points): Positive references with some relevant feedback.

Fair (9-7 points): Mixed references with limited relevant feedback.

Poor (6-0 points): Negative or insufficient references.
