The public was duly notified of the date, time, and place of the meeting.

I. Call to Order.

Mayor Campbell called the meeting to order at **6:00 PM**. A quorum was present.

Mayor Campbell led in the Pledge of Allegiance and Pastor Jeffrey Bradley; Lighthouse Baptist Church led the Invocation. The Town is in compliance with the FOIA, posting 24 hours in advance.

II. Approval of Minutes

1. July 29, 2024-Special Called Meeting

III. Committee Reports Entered at 6:03PM: Planning Commission Report-Wally Shangle

Mr. Shangle provided an update to the Council on the New Comprehensive Plan. The Planning Commission had worked with Gregory Sprouse of the Central Midlands Council of Government to ensure the accuracy of mapping, future land use, and legal compliance. The Commission planned to present the finalized Comprehensive Plan to the Council for review and adoption in September. A digital copy of the Comprehensive Plan was available upon request. Council members were invited to request the original draft if needed, and arrangements would be made to provide it.

IV. Old Business: Hospitality Tax

The Council reviewed the Hospitality Tax Packet and considered hosting a meeting with local business owners to discuss it collectively rather than individually. It was suggested to offer multiple dates and times for this meeting. Mrs. Charlton will contact Naomi Reed at the Municipal Association to arrange suitable dates. This meeting will provide an opportunity for businesses to review the document and ask any questions.

V. New Business: County of Lexington Roads and Storm Drainage Agreement

The Council discussed the County of Lexington Roads and Storm Drainage Agreement. Present were Lexington County Administrator Mr. Lynn Sturkie and County Councilman Todd Cullum, who addressed questions regarding the agreement. The agreement, unchanged except for updated dates, permits the County to maintain subdivision roads built to its standards. Councilman Cullum provided an update on Ramblin Road improvements, noting that resurfacing from Platt Springs Road to Highway 302 is expected to be completed by the end of November. He will confirm the full scope of the project and provide further details to the Council.

<u>Councilmember Prosser made a motion</u> to approve the second and final reading of Ordinance No. 2024-02-B to amend the County of Lexington's animal control ordinance 24-03, chapter 10-animals, article ii, animal control, division I, generally, amending section 10-32-commercial breeding kennels/catteries, section 10-33-dog identification, section 10-38-redemption, mandatory sterilization and microchipping of certain cats and dogs, and section 10-41-per regulation-commercial purposes into the South Congaree code of ordinances, **Seconded by Councilmember Jackson**, No Discussion. Roll Call Vote:

VII. Departmental Reports

A. Interim Police Chief Mike Gordon provided the following update:

The report covers activities from July 1 to the present. Key points include:

- Traffic Tickets: 20 issued.
- Misdemeanor Arrests: 17 made.
- Warrants: A mix of resolved and pending cases, covering a variety of charges.

Regarding calls, Interim Chief Gordon confirmed that the report includes only those handled directly by his department. For calls occurring outside regular hours, he reviews and adopts these from County deputies to ensure complete investigation and avoid duplication of effort.

Current Statistics:

- Total Cases for 2024: 152 as of today.
- *Previous Year's Total:* 424 documented incidents, with some cases related to code violations in mobile home parks.

Homeless Situation: The department continues to address homelessness, which is not a crime but does present challenges. Efforts include managing individuals found in various locations and local businesses. There have been cases involving charging individuals for loitering or vagrancy, and Interim Chief Gordon noted frequent interactions with homeless individuals.

B. Code Enforcement Report - Ronnie Hingleton-Report given by Major Jonas

The Council received an update presented by Major Jonas on behalf of Code Enforcement Official Ronnie Hingleton. Key highlights include:

- Expertise and Progress: Per Major Jonas, Mr. Hingleton has shown significant knowledge and experience, making substantial progress in addressing issues with older mobile homes and properties with excessive code violations.
- *Identification of Problem Areas*: Mr. Hingleton has effectively pinpointed problematic locations, including areas frequented by homeless individuals.
- Compliance Efforts: Notable progress has been made in achieving compliance through proper notifications and enforcement actions. An extensive list of these efforts has been provided to the Mayor and Council, along with positive feedback.
- *Grant Opportunities*: Ongoing efforts are being made to explore matching grants and 100% funding from the Department of Public Safety and the Municipal Association to address specific property issues.

VIII. Public Comments

At the town council meeting, 14 citizens signed up to speak, though only 8 addressed the Council with their concerns and issues. The Council was presented with an 8 question handout from Danny Jones for review and consideration.

IX. Executive Session
